Maanda Anishinaabe Gbeshiigamigoon Mzoowe Tkozhweng Debwetaadwin wii maa'miigwen wii diba'moondiwaa gonda gaa gbesh'idjig zhinda Gbeshii'gamigon maaba Kitchi Gimaaanong Kinadaa gaa naawkiniget.
